2. Value-added courses refer to the courses that are offered to students to enhance their knowledge and skills beyond the regular academic curriculum. Computer education is a popular value-added course that is aimed at equipping students with essential computer skills that can be useful in various fields.

Compulsory computer education is offered as a value-added course, all students are required to take the course as part of their academic program. Computer skills have become essential in today's world, and having a basic understanding of computers and technology can be beneficial for students in their future.

Computer Awareness Level one exam is comprised of a theory exam by the name of Basic Computer Education and Practical exam by the name of Software Lab-1. Exam is conducted annually as per the instructions by the university.

In this way, 5 such programmes have been conducted in last 5 years and a total of 726 students have completed this course successfully in last 5 years.

Teaching-learning and Evaluation

Teaching, Learning and Evaluation is one of the most important components of NAAC Assessment and Accreditation .

The following paragraphs describe the summary of each of the key indicators:

Student Enrolment and Profile: The process of admitting students to the programmes is through a transparent, well-administered mechanism, complying with all the norms of the DGHE Haryana..Approx.70% students are admitted and around 90% seats are filled earmarked for reserved categories as per state govt. norms.

Student Teacher Ratio: The Student-teacher ratio should be optimal to enable teachers to pay individual attention to students to analyze their interests and competence and their learning process, In the last five years our teacher students ratio is approx. 28.63.

Teaching-Learning Process: The learner-centered education through appropriate methodologies such as

participative learning, experiential learning and collaborative learning modes, facilitates effective learning. Digital resources for learning have become available and this makes learning more individualized, creative and dynamic.

Teacher Profile and Quality: "Teacher quality" is a composite term to indicate the quality of teachers in terms of their qualification, teacher characteristics, faculty availability, professional development and recognition of teaching abilities. Our 13 teachers are Ph.D degree holder and approx.. 85% teachers are available in the college as per sanctioned seats and work load during last five years.

Evaluation Process and Reforms: This Key Indicator looks at issues related to the assessment of teaching, learning and evaluative processes and reforms, to increase the efficiency and effectiveness of the system. One of the purposes of evaluation is to provide development-inducing feedback.

Student Performance and Learning Outcomes: Student performance is analyzed in terms of the realization of learning outcomes which are specifications of what a student should be capable of doing on successful completion of a course and/or a programme.

Student Satisfaction Survey: Student satisfaction significantly showcases the actual quality of teaching learning process enabling identification of the strengths of teaching as well as the possible improvements. Student satisfaction, thus, is a direct indicator of the effectiveness of teaching-learning in the institution.

Research, Innovations and Extension

Government College Julana creates an environment for Research, Innovation and Extension activities by promoting incentives to the faculty for research work, organizing field trips, promoting gender sensitivity and community work through NSS, Women cell. Some of the faculty members have completed their research work and some of them are working as research guides. Various teachers have published research papers in different national and international Journals, indexed and referred journals etc. Some of them get their books and chapters published some others present their research papers in National/International and Seminars/conferences and proceedings. Many college Faculty members have already completed their Ph.D. degree and some are pursuing their Ph.D. So the main focus of the college is on teaching but at the individual level, Faculties are doing research and in future, the institute will support staff in organising seminars and conducting research projects. Every department organises various activities such as Poster Making, Slogan Writing, Dialogue conversation competition, Declamation and Quiz Contests, etc. The college has conducted several extension activities in the neighbourhood community under the aegis of NSS, Women Cell, and Youth Red Cross etc. College organises extension activities such as Educational Drive, Health Awareness Programme, Cleanliness Drive, Traffic Awareness Rally, Blood Donation Drive, and Orphanage Visit by students, HealthCheck-up, Swatch Bharat Abhiyan, tree plantation, self-defence training etc. These activities help in the development of students who are socially, politically and economically active citizens. Women Cell plays a crucial role in fostering gender sensitivity. The college has engaged a few Industrial Training Institutes students in college for official activities as part of their practical training. The college organised a District/ State Levelonline Science exhibition. Our college students have won many awards and recognitions in sports. In Sports students has brought Laurels to college. College has also signed MOU with HaryanaPausthikAahar Feed for the betterment of students. College has always endeavoured to launch programs that will create employable manpower in the rural background which is of crucial importance to the country. Students of the college attended training programmes which can prove beneficial regarding their employment in future.

Infrastructure and Learning Resources

The Institution has adequate facilities for teaching learning viz. classrooms, laboratories etc. There are many teaching blocks where classes are conducted by different departments. The college also has an administrative block and around classrooms. Our college encompasses a well maintained campus spread over 16 acres of serene green land that boasts of a lush green surroundings. Tree plantation is a very good exercise which provides a good environment to the learners.

The college has enough infrastructure and facilities which are being upgraded continuously to suit the needs of students. The existing infrastructural facilities are utilized both for conducting theory and practical classes. College has one hall to conduct seminars, and workshops for students and faculty members as well. The college has a large hall for rehearsal of various cultural events and a big Corridor for organizing Poster and Collage Making. College has huge sports complex and open playground. Indoor games are organized in the indoor sports training centre & outdoor games are organized in the open ground and a Gym where students and faculty members do exercises. Common room for girls is available where any sick student can rest or get ready for programmes.

The college has sufficient number of well furnished, well ventilated, spacious fully connected with Wi-Fi 11 classrooms for conducting theory classes. Each department has departmental office to address the student's even personal level doubts too. Computer lab, Chemistry lab, EDUSET, Placement cell in the college is provided with DLP Projector, Computer and Internet. There are 79 computers which used in Chemistry lab, Physics lab, computer labs, language lab and placement cell of the college. Along with the traditional chalk/ white board teaching aids the college has incorporated with fully Wi-Fi teaching classrooms, labs and projector facilities, fully automated library and one EDUSET room to enhance the ICT facilities in teaching methods.

The college library, departmental libraries and placement cell are the valuable sources of information, with approximately 9000 text books, reference volumes and subscription of e-journals. The library is totally automated with INFLIBNET's integrated library management software, SOUL, version 2.0.0.12, which was installed in 2014.

Student Support and Progression

Govt. College, Julana is taking various initiatives to overcome these shortcomings by working closely with the Industry Associations and other stakeholders to augment placement opportunities for students in Haryana across select degrees in accordance with the conditions to raise the employability of students. The state government of Haryana plans to offer an opportunity for employment to its final year students who are pursuing non-technical degrees (i.e. B.A. / B. Sc. / B. Com.).

The college is ready to adopt the same vision and follow the curriculum of the parent university in letter and spirit. Proper synergy is the need between skill development and industry and to vocationalise the education with mainstream education with earned credits in a phased manner. The Institution is deeply committed to develop the skills as an essential part of education. Different MoUs has been signed by the Institution with various skill based enterprises and many others are in pipeline for the near future.

Scholarships are offered by Department of Higher Education, Haryana through the college for deserving and needy students to encourage them to take up Higher education. This incentive falls in line with the motto of Higher Education of the State: Access, Equity and Quality. Generation makes Nation.

Govt. College Julana has registered its Alumni Association in the year 2020 that is named as Alumni Association of Govt. College Julana (Jind). The multidimensional aims and the objective of the Association are like to promote and foster mutually beneficial interaction between the Alumni and the Alma Mater.

Students are trained in sports and encouraged to participate at various levels of competition including Intra college events, Inter-university events, National events, and international events under the supervision and guidance of the sports department of the college. Intra- college events are organized every year by the college.

The college conducts various cultural programs every year for the students. Cultural festivals like "Swar Nirjhar" and "Talent Search" are organized every year for first-year students to search for talent among new students. Apart from this, students also represent the college in a Youth festival organized by the CRS University (Jind).

For this purpose, Institution is in the process of creating centralised database of the college students. Through this database, where in the academic credits earned by the student from various courses will be digitally stored so that the credit earned by student previously could be forwarded when the student enters the program again. For monitoring ABC, proper technical support system will be created.
3. Skill development:	Keeping in view the growing demand for skilled work force in both public and private sector, Higher education institutions are framing their curriculum accordingly. Over the past few years, educationists have introduced many skill-oriented courses in the curriculum. The need of the hour is to produce young generation obtaining degrees in their choice of subjects and additional skill courses that will help them to start their entrepreneurship after leaving the college. In this way a graduate from the college will become a job provider rather than a job seeker. Our college is ready to adopt the same vision and follow the curriculum of the parent university in letter and spirit. 1.3 Curriculum Enrichment

1.3.1 Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability in transacting the Curriculum

Response:

The college is intended to sensitize its staff and students on issues relating to human values. Values are

something which are desirable and worthy of esteem for their own sake. Human values help us to live in harmony with the world. We have taken all efforts and initiatives to integrate cross-cutting issues relevant to Gender, Environment and Sustainability, and Professional Ethics into the Curriculum. In addition to this, the College has constituted various cells like Women Cell, Legal Cell, NSS Cell, placement cell to incorporate and imbibe among the students issues related to Gender, Environment and Sustainability and professional ethics.

Curriculum content appreciates the ethical, cross-cultural, environmental issues and the links between human and natural systems. An environmental study is compulsory for all the streams. Its syllabus is adopted as prescribed by UGC. This enables the students to learn about the ecosystem and other environmental factors. They also learn measures to protect the environment and are made aware of global warming and other related issues.

The institute tries to produce human, professionally ethical, gender sensitized and environmentally conscious students through effective delivery of the syllabus provided by the affiliating university i.e. C.R.S.U. Jind. Different papers of the syllabus cover relevant issues and help in preparing students for the challenges before us.

PROFESSIONAL ETHICS:

In a world of cut throat competition students need to be made aware about ethics to be observed in their professional life. Several papers in B.Com help in developing such ethics. Business Ethics and Organisational Behaviour are taught in Commerce stream.

HUMAN VALUES:

Formal educational institutes have to play a big role to tackle the moral crisis before humanity. Thus several papers are introduced in the syllabus to develop moral values in the students. The whole syllabi of English and Hindi serves this purpose because literature aims at inculcating human values in readers. Preachings of Bhakti and Sufi saints are introduced in papers of History.

Different papers of English and Hindi are dedicated to the problems faced by women in society, contribution of women in literature, how they are portrayed in literature and role of eminent feminists in gaining equal rights for women. Business Ethics throws light on issues of gender sensitization, gender

equality, gender roles and gender differentiation.

ENVIRONMENT:

2.3.1 Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

Teaching-learning methods adopted by the faculty members include Lecture method, Interactive method, Discussions, experiential learning etc. The teaching -learning activities are made effective through illustrations and special lectures to acquire basic understanding on the subjects and current practices students are engaged in the field study.

- 1. Lecture Method: This conventional method is commonly adopted by all the teachers. This method facilitates the teachers to interpret explain and revise the content of a text only for better understanding of the subject by the learners. Problems are solved at the class level by encouraging questions in the class.
- 2. **Interactive method**: The faculty members make learning interactive with students by motivating student participation in group discussion, subject quiz, news analysis, discussions and question and answer on current affairs. Discussions: We do follow the discussion in many of the subjects as it make the students to think wide and participate in coming up with the opinions & suggestions to check their current knowledge.
- 3. **Debates:** Debates are followed in many of the subjects where students are required to come with different opinions, thought processes thus the learning process gets justified in argue mental way of learning.
- 4. **Experimental learning**: The faculty members foster learning environment by engaging in rich experimental content of teaching through experience, teaching through demonstration, visual aids, organizing exhibitions, participating and conducting quiz on theory topics. We try to expose our students to all the laboratories like physics, chemistry, computer and geography. Students related to various subjects are given an in-depth knowledge based on the potential of the student so that student can learn it by experience.
- 5. ICT enabled teaching:ICT enabled teaching includes Wi-Fi enabled computer Labs with projector and E-learning resources. The institution adopts modern pedagogy in line with emerging trends to enhance teaching-learning process. The institution has the essential equipments to support the faculty members and students. College has computers, broadband, Wi-Fi connections to supplement the knowledge of teachers and students. Learning through internet, use of Edusat and different type of laboratory instruments has made the teaching more effective. Teachers have the expertise and abilities to assist all students in achieving high academic standards by utilizing new digital tools. The college features a Wi-Fi-equipped campus, allowing teachers and students to stay connected while learning and imparting current information. To aid in the E-learning process, the college has ICT-Enabled computer labs with projectors. Scanners and Printers are available in Labs, HOD rooms, and prominent places. The faculty members take practical classes for the practical basedCourses. Specific courses like computer science, Math, Physics and Geography have practical omponents that necessitate the use of computer laboratories. Govt. College, Julana is affiliated to C.R.SU.Jind. The College follows the guidelines issued from time to time by the University for award of Internal Assessment. Thebreakup of Internal Assessment as prescribed by the University is as follows:

- 1. 25% for Attendance
- 2. 50% for Assignments/Presentation (better of two)
- 3. 25% for Class Test

The marks for attendance are awarded to the students based upon the following criteria (in case the internalassessment is of 20 marks):

- 1. Less than 65 % attendance -0 Marks
- 2. Upto 70 % attendance 2 Marks
- 3. Upto 75 % attendance 3 Marks
- 4. Upto 80 % attendance 4 Marks
- 5. Above 80 % attendance 5 Marks

Assessment of performance is an integral part of teaching and learning process. As a part of sound education strategy, the institution adopts centralized continuous and comprehensive internal evaluation system designed by C.R.S.U. Jind to access all aspects of a student development on a continuous basis throughout the year. The continuous internal assessment and evaluation pattern of undergraduate student.

The faculty members of the college use both formative and summative approach for the assessment of the students and External examiner evaluate them during practical exams. Internal assessment marks and practical marks are uploaded on university website online.

The formative approach includes:

Group Discussion, Debate, Declamation and Quiz Contest.

Summative approach includes:

1. At the end of a chapter, a test is taken.

2. Mandatory Class Test month wise.

3. At the end of semester, exam is conducted.

College level grievance redressal committee looks after the grievances related to academic and nonacademic matters. **Grievance Redressal Cell** helps the students to approach for general and personal grievances. All the queries or complaints (if any) related to examination are dealt with efficiently. We follow a thoroughly transparent system of exams and assessment. The checked answer books as well as the attendance are shown to each student. If they have any doubt, they can raise it there and then itself before the Incharge. If not solved satisfactorily by the Incharge, the head of the department takes the matter into consideration and resolves it. But at later stage also, if a complaint is filed with the committee immediate attention is paid to it. The problem is discussed, solution is sought and student is intimated with the solution. The Practical examinations are conducted in the time frame provided by the University. The External examiners are appointed from the Panel List provided by the University as far as possible. The final semester examinations are conducted as per the date sheet provided by the University and the instructions issued by the University are followed for conduct of examination. Students are informed of the schedule of Theory /practical examinations timely through WhatsApp group,

College Website and on Display Boards.

3.4 Extension Activities

Response:

The library encourages students to read and develop the habit of reading and learning. It motivates them to read more and broadens their knowledge. Our college library is a valuable source of information, with **8172 text books, reference volumes and subscription of e-journals.** The library is totally automated with INFLIBNET's integrated library management software, **SOUL**, version 2.0.0.12, which was

installed in 2014. It is user-friendly software developed to work under client-server environment. This programme is used for various library housekeeping tasks such as data entry, book issuing and return, book renewal, and so on. The reading and reference sections of library are wide and well-ventilated. Students and faculty can now look for books by subject, author, accession number, and title. Every day, approximately 100-150 students and faculty members visit the library, in which there are separate reading sections for academicians, Girls students and Boys students. The library is fully automated, with photocopiers and printers, as well as a digital database, CDs, and DVDs. The library staff is responsible for the reading room's upkeep as well as the stock verification of library books. The Library Advisory Committee invites demands of books and magazines, to be purchased and the journals to be subscribed are as per the requirement of HODs of different departments. The list is finally approved by the Principal after its finalization. The visitors' register is also kept to keep track of readers and learners, as well as to ensure that books are returned timely. Before appearing in exams, all students must get the "no dues" of the library.

4.3 IT Infrastructure

Response:

Govt. College Julana (Jind) is committed to build technologically intensified active learning environment based on ICT in education and management of student life as well as administrative purpose. College pays great attention towards maintenance of IT facilities with continuous up gradation.

At the beginning of the academic year, need assessment for replacement/up gradation/addition of the existing IT infrastructure is carried out based on the suggestions from Head of the Departments and after reviewing the course requirements. There are 79 computers which are being used in Computer Labs, Language Lab, Chemistry Department, Physics Departments and Placement Cell of the college. Two computer labs have fifty computers and one language lab Twenty five computers have been set up in the college. All the computers in the labs are connected with Broadband Internet facility and are open throughout the working hours for staff and Students. A Lab Attendant has been appointed to take care of the repair and maintenance and Updating of labs.

New desktops of latest version are added from time to time and non-functional parts of working computers are repaired and replaced according to demand. Annual quotations are being called and rates of distinct

computer accessories, cartridge refilling and parts to be repaired are finalised to overhaul the IT infrastructure of college. The desktops in all the labs have office automation package like MS Office and latest updates. Students are being provided all standard statistical, computational and scientific packages like FORTRAN-95, JAVA, C, C++, visual basics, HTML, maths SPSS, Tally, MATLAB etc. as per curriculum.

Along with the traditional chalk/ white board teaching aids the college has incorporated with fully wi-fi teaching classrooms, labs with fully wi-fi and projector facilities, fully automated library and one EDUSET room to enhance the ICT facilities in teaching methods.

The college has purchased OFC based leased line connection from BSNL in 2020 of 50 Mbps speed and the college campus was made Wi-Fi enabled with Wi-Fi routers having highest bandwidth.

During the past COVID-19 lockdown, the teachers remained connected with their students and used innovative teaching aids such as google meet, Webex, zoom etc. and assignments and tutorials being uploaded on LMS (Learning Management System) /Shiksha Setu app which are functional under the parent Higher Education Department of Government of Haryana.

The college website www.gcjulana.ac.in is another important IT based interface which provide effective, efficient and transparent services to all the stake holders. All the crucial information about the college, teaching departments, faculties, latest news/notices, admission rules, college societies and other vital information are all available on the website. The information of different events organised in the college is shared along with photographs on the college website and Facebook page as well. The IT Cell and its support staff will maintain the servers and the Campus WiFi. The maintenance of computers in the departments including the required software installation, antivirus and up gradation, electronic gadgets like projectors, printers, and photocopiers are maintained by respective departments.

Various cells and, societies are also actively involved in several activities and the participation of students is ensured with positivity and timely.

Leadership organizational programmes are promoted and reassured in the societies. Faculty members

supervise and manage the activities of these bodies. The faculty plays a significant role in the planning and effective implementation of the college administrative process. Responsibilities are delegated to them based on their competence, commitment and aptitude to meet the institutional objectives. Teachers and students work with a co-operative spirit, helping and motivating each other and encouraging every individual to grow. In addition to them there are also non-teaching staff like LA etc. They are responsible for maintaining of equipments in the labs for smooth functioning of the practicals in the department.

Case Study of Science Exhibition: Decentralization and participative management in the institution is very well reflected in science exhibition. The main objective of science exhibition is to promote interest in science and technology among younger generation. Principal appoints a convener every year. Convener prepares a plan under the chairmanship of Principal for proper utilization of grant. Grant is distributed among four departments: (Physics, Chemistry, Computer Science, and Geography). Then a suitable date is decided for holding science exhibition at college level. After that a notice is displayed by each department. Each department prepares at least ten (10) projects with two students in each project. Projects are displayed on the decided day of science exhibition. Each department declares their best explanator and project with first three positions. Project with 1st position from each department is selected for competing at district level. In this way, students are able to interact with their peers. Science exhibits with first position at district level participate in state level science exhibition.

6.3 Faculty Empowerment Strategies

6.3.1 The institution has performance appraisal system, effective welfare measures for teaching and non-teaching staff and avenues for career development/progression

Response:

Welfare measures for teaching and non-teaching members are not only for the development of staff but also for the organization development. Our college tries to implement any of the welfare schemes launched by the Government of Haryana/University for the employees. Various effective welfare measures which are implemented by our college for the teaching and non teaching staffs are as follows:

1. Casual Leave: Casual leave is granted to teaching staff and nonteaching staff to attend personal matters.

2. **Earned Leave:** Both teaching and non-teaching staff is provided with earned leave as per the Haryana government rules.

3. **Duty Leave:** Duty leave is provided to the teaching staff for participating in Orientation Programme/Seminars/Conferences, for practical examinations, flying duty or any other work related to the institution as per Haryana Government rules .

4. **Study Leave**: Study leave is provided to the teaching staff for higher education such as Ph.D as per Haryana Government rules.

5. **Maternity Leave:** College renders a full paid maternity leave for six months to eligible female staff and for a period of 45 days in case of miscarriage including abortion as per the government rules. There is provision of paternity leave of fifteen days for male employees also as per rules.

6. **Child Care Leave:** Child-care leave is granted to the women employees for a maximum of two years during the entire service before their child reaches the age of 18 as per Haryana Government rules.

7. LTC: Leave travel concession is provided to the both teaching and non-teaching staff as per the

government rules.

8. **Children Allowances:** Both teaching and non-teaching staff can draw children education allowance, which shall be admissible in lieu of reimbursement of tuition fee as per Haryana Government rules .

9. **GIS:** Group insurance scheme is available for teaching and non-teaching staff to support in the unfavorable conditions as per Haryana Government rules .

10. **Provident Fund :** General Provident Fund (GPF) and National Pension Scheme(NPS) are provided to the employees where GPF is for those employees who joined service up to 31-12-2005 and NPS is for those who joined service from 01-01-2006 as per Haryana Government rules.

12. **Medical Reimbursement:** Medical reimbursement facility is provided to the both teaching and non-teaching staff as per the government rules of Haryana.

13. Annual Increment: Annual increments and promotional benefits are given as per the policy.

14. **Retirement Benefits:** Pension, family pension, Gratuity, Leave encashment as per Haryana Government rules.

15. **Sports events and Health check-up camps:** Our College organizes sports meet and health checkup camps for teaching staff and non- teaching staff.

16. **ICT and other facilities:** Internet, Free Wi-Fi facility and subsidized canteen is there for the teaching and non- teaching staff. Also, ramps are there for disabled staff.

17. Other Allowances: Non- teaching staff gets washing allowance as per government rules.

18. **Social staff events:** Committee under social staff secretary is constituted for organizing retirement parties, promotional parties, condolence meeting and other activities related to teaching faculty.

6.4 Financial Management and Resource Mobilization

6.4.1 Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

The college is a government establishment and works strictly as per the financial rules and regulations made by the Finance Department, Government of Haryana. There is a system of regular periodic audit of expenditure incurred by the college to ensure strict adherence to procedure in spending money and to ascertain whether these expenses are incurred economically and only for the purposes for which they have been approved.

Internal Audit:

The college has a designated Financial Officer 'Bursar'. The Bursar' checks and verifies all the vouchers of the transaction with reference to the approved budget and availability of college funds as per rules. He advises the principal on financial record keeping and ensures integrity of financial accounts. The internal audit is conducted by the auditor of the Higher Education Department, Haryana. Regular monitoring by the internal financial officer-cum-auditor (Bursar') is very effective in ensuring that all financial transactions are carried out in accordance with government rules and regulations in the institution. In addition, Stock Verification Committees are appointed by the principal to examine and verify the available stock at the end of each financial year. Further, the committee recommends auction of stock items if found non-operational. The cash -book is prepared regularly by the office staff and attested by the Bursar' and countersigned by the Principal.

External Audit:

External Audit is conducted every 2-3 years as per government norms. Periodically, the Accountant General of Haryana's audit team examines the state government's financial records. The audit report is released by the Chief Accounts Officer of Haryana when the audit is completed. There are two types of

financial resources: First is government grants received from the Department of Higher Education, Haryana and second are funds and fees received from students as per rules.

Financial Audit includes:

Funding towards Placement Cell, Women's Cell, Earn While you Learn, Lab up gradation, conferences, and office expenses (O/E), seminars, workshops, conferences are audited and thereafter utilization certificate is also submitted. The college collects fees from the students under various Heads like Amalgamated Fund, University Fund, Red Cross fund, R.K. Fund, Dr. A.P.J. Abdul Kalam Fund, Sports Fund, Development Fund, Library Fee, electricity charges, NSS etc as per rules. As per rules, cash-books and stock registers are also maintained for different funds separately. The audit of the student's funds is done by the Local Audit Haryana. The expenditure bills of all the Govt. Grants is submitted to treasury and the amount is transferred through RTGS/NEFT to the vendor's bank account. The auditor ensures that all payments are duly authorized as per Haryana Government rules. After the audit, the audit report is sent to the college for review positively. Any queries in the process of audit would be attended immediately along with the supporting documents within the prescribed time limit. The college did not come across with any major audit objection during the preceding years. The authority of the institution and Accountant General, Haryana duly signs the audited statement as per rules.

One such initiative for academic audit is PRAYAAS (Performance Rating Yardstick for Academic Audit Standard) by Department of Higher Education. Data and record required to fulfill the yardsticks fixed by Department of Higher education is prepared and maintained by IQAC.

The Women Studies and Development Cell of the college began with an objective of empowering the girl students in all spheres of national and global life.

Participation of more no. of Girls students in Various activity :

Government College Julana has about equal strength of the girl and boy students. In the college, the participation of the girl students in various activities and competition as quiz competition, speech and slogan competition, poem and singing competition etc. and the participation of girls is always more than the boys. The women cell activities of the college also provide a platform to the girl students to express their self. The 'Talent Search' and 'Swar-Nirjhar' programmes organised annually from the beginning of the college and the participation as well as the winning post of the girls is always more than the boys. By the end of the session, every year, the students of Second Year (B. A., B. Sc, B. Com.) arrange a farewell party for the students of final year and the whole programme is arranged by the students mainly girl students of second and final years.

Provide decision-making environment to Girls students :

In co-curricular activity of the college, the participation of girl students is always more than the boys. Even

many programmes of the college manage by the girl students. The college student council leaders are also girls who take every decision of the students' welfare and also represent the students in every issue related to them.

Providing leadership space to Girls students

In the first college election (2018-19), the participation of girls was commendable. From out of total 10 fighting candidates of class representatives, 06 candidates were girls and from the total 09 winning class representatives 06 were girls show the women friendly environment of the college. Even the official post of student council the president, secretary, and joint secretary were also girls named Bindu, Deepika and Sonia respectively. In this way the college provide an equal leadership space to the girl students.

Activities to improve the skills of girl students

The women cell of the college is working continuously to polish the talent and skills of the girl student of the college. Women Cell of the college organises workshop time and again. From the year 2017-18 to 2021-22 the women cell of the college organised various workshops such as: workshop on beautification and hair style, workshop on art and craft, workshop on sewing training, workshop on cutting and stitching, workshop on sweater knitting, workshop on canvas painting, workshop on self-empowerment, workshop on beautification and hygiene, workshop on best out of waste etc. This type of workshops gives an opportunity to the girls to become economically empowered or frame their professional carrier.

Haryana Government announced the 'Earn while you learn' scheme for the students in government college across the state. This scheme is being run successfully in the Government College Julana. The college provide equal opportunity to the girl students for taking the benefits of the scheme and the girls also take part in it.
